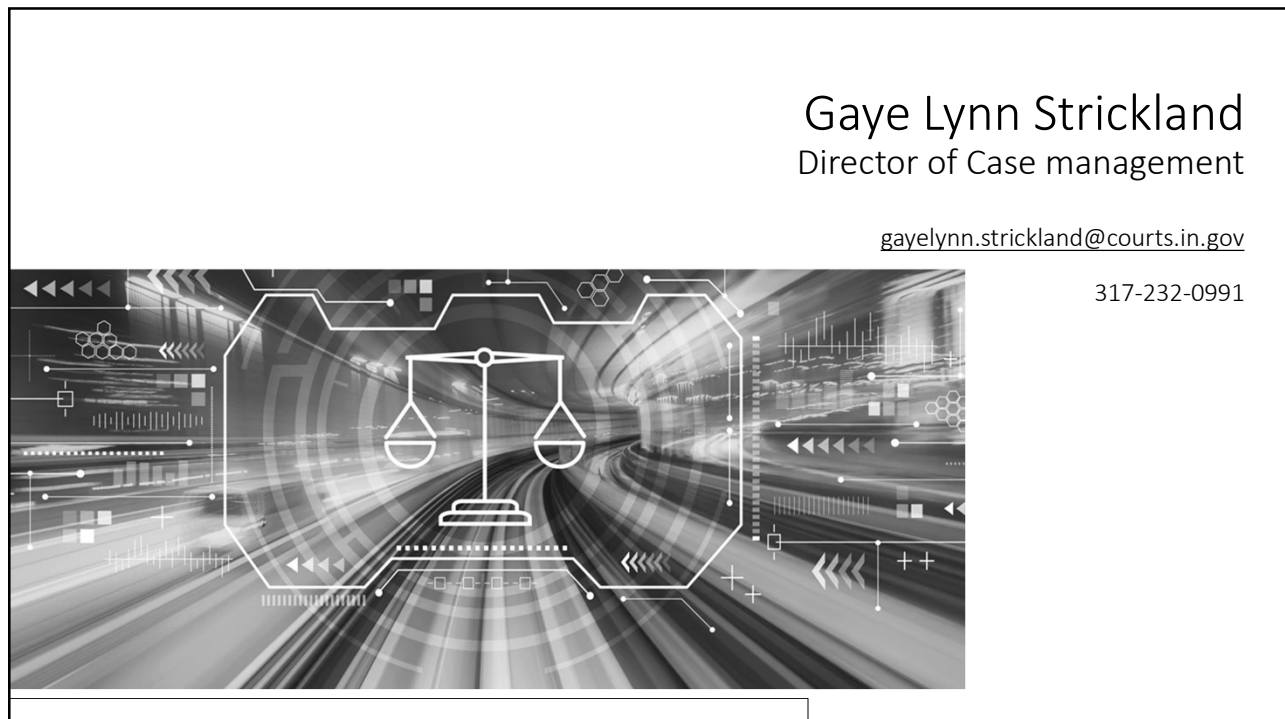


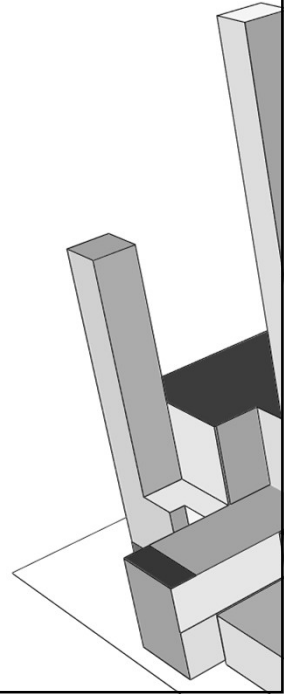

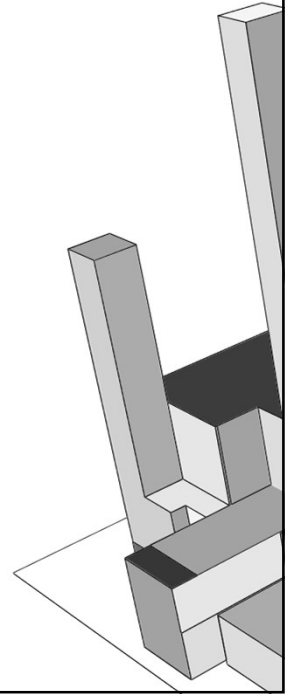

INfile – Indiana E-filing System

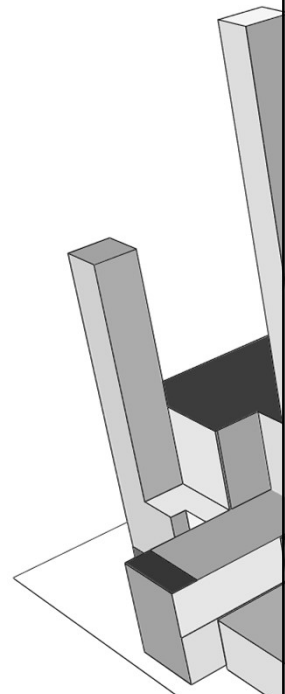
- Replacing current Tyler-provided services with IOCT's new INfile system.
 - New free e-filing service provider used by filers
 - New e-filing manager accepting and routing envelopes
 - New Clerk review application
- Will combine criminal and civil e-filing into one review application
- Implementation in Q4 of 2025



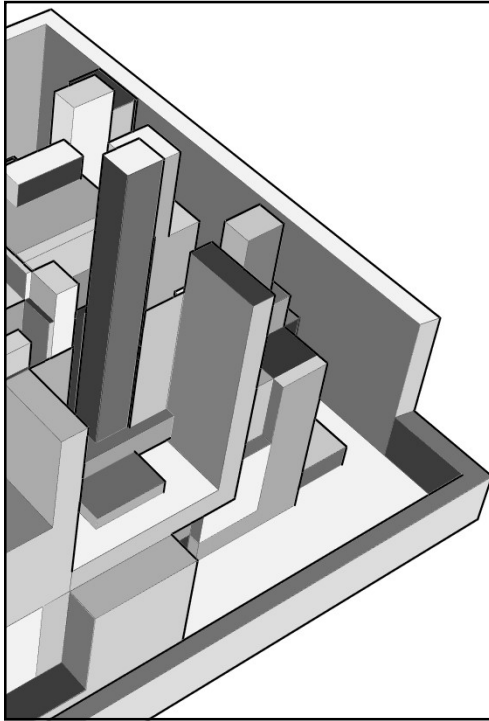

- If you are a Quest County, expect a call from Beth Fullen regarding case type configuration.



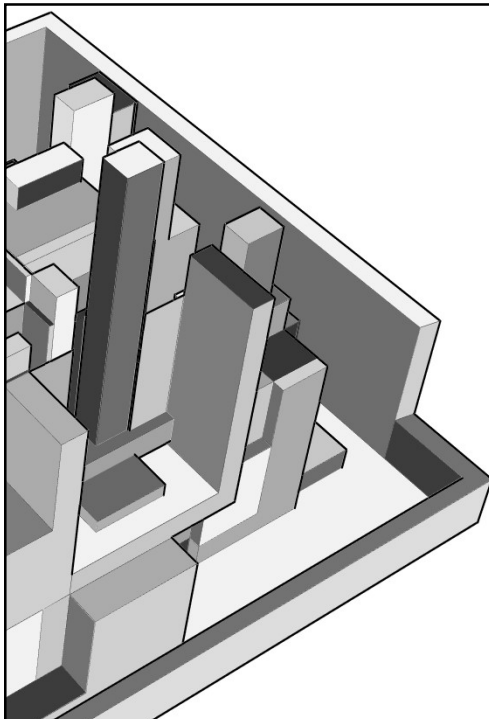

CHRIS Interface

- Police arrest an individual and send that arrest info to ISP
 - Fingerprinting at arrest generates a TCN number that follows this case through the system.
- Prosecutor determines if they file charges and send that file/no file info to ISP.
- Case gets disposed and statute says Clerk shall send disposition to ISP.
 - But we have to have the TCN
 - There may be errors that need resolved

CHRIS Interface

- Why it matters
 - ISP sends felony convictions to NICS to prevent individuals from obtaining firearms
 - Information on the CHRIS errors list has not updated the individual's criminal history. Anything not on the criminal history will not return on background checks.
- Who works the errors list?
 - IOCT does not dictate that, but someone in your county's court/clerks office should.
 - Consider turnover. Multiple people should receive the report and know why.

Records retention and historical files

- Trial Rule 77 says you must have one complete file, either electronic or paper.
 - Old file all paper, no current court activity on case? No scanning in Odyssey.
 - Old file all paper, new motion/action filed on case (not including expunging current case). Either scan the old file to Odyssey or print the scanned for the paper file.
 - Old file some paper, some scanned in Odyssey? Either scan the old file to Odyssey or print the scanned for the paper file.
- Clerk Receives \$5 per case for records retention. Retaining old, non-Odyssey records is the county's responsibility.
