 - Online
 - May 31 July 22
 - Paper-and-Pencil
 June 6 July 22







- ISTEP+ Part 2 Administration Mode
 - Percentages from Pearson as of April 6, 2016

Online: 82.76% Paper/Pencil: 17.24%



- Practice Test Administration Flexibility
 - Use items instructionally (guidance provided)
 - Administer as a "test setting" optional
- Practice Test Not Timed
 - Allows students to practice item formats without feeling rushed; provides opportunity for students to ask questions
 - Some sites (mostly high schools) requested "time limit" for planning purposes – times allow opportunity for students to ask questions

Practice Test Comprehensive

- Item types based on Pearson platform include:
 - Multiple-choice
 - Multiple-choice 2-part
 - Multiple-choice 3-part
 - Multiple-correct response
 - Gridded-response
 - Technology-enhanced

- RE: ISTEP+ Part 2 Assessment Date Change Requests
- **DATE:** April 15, 2016

The State Board of Education provides authority for the Indiana Department of Education to review and approve requests to begin testing up to seven calendar days in advance of an established testing window. All other requests to begin testing any earlier require review and approval by the State Board of Education.

Six (6) requests for a date change of seven days or less were approved by the Indiana Department of Education (see Appendix A). The Department received no requests requiring State Board approval.
