RE: Approval of Governing Body Change – Paoli Community School Corporation

Recommendation: Approve the proposed governing body plan change

Pursuant to IC 20-23-8, the Board of School Trustees of Paoli Community School Corporation ("Paoli") adopted a resolution to initiate a change to Paoli's governing body plan. After adopting the resolution, Paoli submitted the attached materials for the Indiana State Board of Education's ("Board") review and consideration, in accordance with the requirements set forth in IC 20-23-8-15.

Indiana Department of Education ("Department") staff reviewed the attached material and determined that Paoli's plan and the manner in which it was initiated satisfy the requirements set forth in IC 20-23-8. As such, Paoli's new governing body plan is recommended for approval.

A RESOLUTION INITIATING AN AMENDED AND RESTATED PLAN OF ORGANIZATION CHANGING THE GOVERNING BODY TO RESIDENTIAL DISTRICTS

WHEREAS, Paoli Community School Corporation (hereinafter "PCSC") was created pursuant to a countywide school reorganization plan that was adopted pursuant to the School Reorganization Act of 1959; and

WHEREAS, the Board of School Trustees (hereinafter "Board") of PCSC is now constituted as a seven-member non-partisan elected Board with three (3) members residing in and elected by the voters in the Town of Paoli (District One); two (2) members residing in and elected by the voters of Paoli Township and Greenfield Township (District Two); and two (2) members residing in and elected by the voters of Southeast Township and Stamperscreek Township (District Three); and

WHEREAS, subsequent shifts in population have caused the current Board to conclude that there should be initiated a proposed plan to change the method of electing the PCSC Board, so that residency requirements of members are retained, however, all voters in the Paoli Community School Corporation will vote for all candidates; and

WHEREAS, the provisions of Indiana Code ("IC") 20-23-8, et. Seq., provide the Board with the authority and designated processes by which such a proposed plan to change the composition of the residential districts that comprise a governing body of a public school corporation might initiated, advertised and ultimately adopted;

NOW, THEREFORE, BE IT RESOLVED by this Board that pursuant to the provisions of IC 20-23-8-10(a)(2), it hereby adopts the following changes in the PCSC Organization Plan by which members of the PCSC Board are to be elected following the Effective Date hereof, as set forth below.

AMENDED AND RESTATED PLAN FOR CHANGE TO RESIDENTIAL DISTRICT COMPOSITION OF GOVERNING BODY

A. Board of School Trustees (Board) of the Paoli Community School Corporation (PCSC)

1. <u>Number & Residential Districts-</u> The governance of PCSC shall be vested in a non-partisan Board composed of seven (7) members elected at a November general election in accordance with the provisions of IC 20-23-4-29.1 and IC3-8-2.5. Members shall be elected as follows:

District One (Paoli Town): Three (3) members shall be elected by all eligible voters in the Paoli Community School Corporation. Those three (3) members shall reside within District One at the time of election, in the school corporation for a least one (1) year immediately before taking office and in the state for at least two (2) years immediately before taking office.

District Two (Paoli Township and Greenfield Township): Two (2) members shall be elected by all eligible voters in the Paoli Community School Corporation. Those two (2) members shall reside within District Two at the time of election, in the school corporation for at least one (1) year immediately before taking office and in the state for at least two (2) years immediately before taking office.

District Three (Southeast Township and Stamperscreek Township): Two (2) members shall be elected by all eligible voters in the Paoli Community School Corporation. Those two (2) members shall reside within District Three at the time of election, in the school corporation for at least one (1) year immediately before taking office and in the state for at least two (2) years immediately before taking office.

- 2. <u>Term of Office-</u> Membership on the PCSC Board shall constitute the holding of a "lucrative office" as said term is used in Article 2, §9, of the Constitution of the State of Indiana. Members shall be elected to a term of office of four (4) years commencing as of January 1 of the year following the year of their election.
- 3. <u>Organization and Appointment of Officers-</u> The Board shall annually organize within fifteen (15) days after the commencement date of the members' terms of office, or within such time as might otherwise be required by applicable law. The Board shall select from

- among its membership a president, vice president and secretary, each of whom shall be a different member of the Board. The Board may make such other appointments as permitted by, and in accordance with, applicable law.
- 4. <u>Compensation-</u> Members shall be entitled to compensation for the performance of their duties on the Board, as limited by applicable law and as determined, from time to time, by resolution of the Board.
- 5. <u>Eligibility for Membership on Board-</u> To be eligible to serve on the Board, a candidate for election to the Board must have attained the age of twenty-one (21) years prior to the date that the candidate's term of office would begin. Property ownership shall not be an eligibility requirement for a candidate seeking election to the Board.
- 6. <u>Vacancies on Board-</u> Vacancies on the Board existing because of the death of a school board member shall be filled in the manner provided by IC 20-26-4-4.5, as from time to time amended. Vacancies on the Board existing for any reason other than the death of an elected, qualified and acting school board member shall be filled in the manner provided by IC 20-26-4-4, as from time to time amended.

B. Transition Plan Pending Board Elections

1. <u>Schedule of Current Board Terms and Listing of Current Residential Districts</u>- The terms of office of the current members of the Board, their respective residential election districts, their last election dates, their next election dates and the dates of seating following their next election under the existing PCSC governing body selection plan are as follows:

- 2. <u>Transition of Residential District Representation-</u> The representation of the existing residential districts shall be transitioned under this proposed plan change in the following manner:
- a) In the November, 2022, general election, the terms of members Lila Tucker (current District One); Doug Pittman (current District Two); and Bill Hoke (current District Three) would end at the year end and their replacements would run as candidates to be voted on by all eligible voters in the PCSC. Each of the elected replacement candidates would commence his/her term of office as of January 1, 2023, and those terms would end as of the December 31, 2026.
- b) In the November, 2024, general election, the terms of members Lora Sanders (now in District One); Terry Nicholson (now in District One); Craig Starr (now in District Two); and Joe Kimmel (now in District Three) would end at year end and their replacements would run as candidates to be voted on by all eligible voters in the PCSC. Each of the elected replacement candidates would commence his/her term of office as of January 1, 2025, and those terms would end as of December 31, 2028.
- 3. <u>Election Date for Board Members under Proposed Plan Change-</u> Upon passage of this proposed plan change and its becoming effective upon the Effective Date, all members of the Board will be elected at general elections held in November of the appropriate years as set forth above (assuming this proposed Plan Amendment is approved in time for the declaration of candidacies for the 2022 November general election).
- 4. <u>Retention of Terms of Originally Adopted Plan of Organization-</u>Except as specifically modified herein all other terms and conditions of the original PCSC Plan of Reorganization, as approved by the Indiana State Commission on School Reorganization on or about shall remain fully effective after the Effective Date hereof.

C. Effective Date

All aspects of this proposed plan change shall become effective as of its certification by the Indiana Department of Education or on May 01, 2022, whichever is the earlier (assuming no protest petitions to this Board initiated plan or alternate plans are filed).

BE IT FURTHER RESOLVED that the Secretary of this Board is directed to cause notice of this Board's adoption of the foregoing plan to be published, as required by the provision of IC 20-23-8-14, in a newspaper of general circulation published in Orange County,

BE IT FURTHER RESOLVED that the superintendent, school corporation legal counsel and the officers of this Board shall take all other actions and execute all other documents as are reasonably convenient or otherwise necessary to affect the change in the plan for the selection of this governing body as hereinabove set forth.

REGULAR SESSION

At 5:37 P.M. on Monday, December 13, 2021, the Board of Trustees of the Paoli Community School Corporation met in Regular Session.

Call to Order and Roll Call were given with the following Members present: Lila Tucker, President; Terry Nicholson, Vice-President; Joe Kimmel Secretary; Bill Hoke, Member; Doug Pittman, Member; Lora Sanders, Member; and Craig Starr, Member. Also present were: Greg Walker (Superintendent); Sherry Wise (High School Principal); and JC Tucker (School Attorney).

The Pledge of Allegiance was recited.

The Board reviewed the Paoli Community School Corporation "Return to In-Person Instruction" Plan. The public was given an opportunity to comment on the plan. There were no changes made to the plan.

Tammy Miller and Mary Anne Knapp gave a presentation on Readable English.

Tammy Noble and AVID students shared information on the Paoli Jr.-Sr. High School AVID Program.

r'aoli Jr.-Sr. High School updates were given by Dr. Wise. Mr. Walker shared Throop Elementary updates for Mrs. Crews.

Lola Beavers and Taisha Robbins were recognized as Students of the Month for PHS. Mrs. Crews had shared her presentation with the Board for all the Throop Elementary Students of the Month.

Mr. Pittman made a motion to approve the consent agenda items requiring approval: Vouchers and payroll registers as presented; and the minutes of the November 15, 2021, Regular School Board Meeting, as written. Mr. Hoke seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said requests and informational items, including financial reports, are attached hereto and made a part of these minutes.

Attorney, J.C. Tucker, presented three options for Board Re-Districting. There were no comments from the public.

Mr. Hoke made a motion to approve the Resolution Initiating an Amended and Restated Plan of Organization Changing the Governing Body to Residential Districts. Mrs. Sanders seconded the motion. Mr. Hoke, Mr. Nicholson, Mr. Pittman, Mrs. Sanders, Mr. Starr, and Mrs. Tucker voted in the affirmative. Mr. Kimmel voted in the negative. The motion passed (6 "Yes", 1 "No"). A copy of said Resolution is attached hereto and made a part of these minutes.

The Board considered bids on No. 2 diesel fuel and non-leaded 87 octane gasoline. A bid was received by iley Oil Co., Inc. in the amount of \$2.938 for diesel fuel and \$2.566 for gasoline. Mr. Hoke made a motion to accept the bid submitted by Riley Oil, Inc. on No. 2 diesel fuel and non-leaded 87 octane gasoline. Mr. Nicholson seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No").

Mr. Starr made a motion to approve the Schools Attorney Contract for calendar year 2022 submitted by James C. Tucker. Mr. Kimmel seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 No"). A copy of said contract is attached hereto and made a part of these minutes.

Mr. Walker gave the second reading of Neola policy updates Number 34, Volume 1. Mr. Nicholson made a motion to approve the Neola policy updates Number 34, Volume 1. Mr. Pittman seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No").

Mr. Pittman made a motion to approve the Memorandum of Understanding between IU Health SCR Community Health and Paoli Community School Corporation School to provide and support Coordinated School Health to Paoli Schools. Mr. Nicholson seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said Memorandum of Understanding is attached hereto and made a part of these minutes.

Mr. Hoke made a motion to approve the agreement with Southern Indiana Community Health Care to provide services to students and staff of Paoli Community School Corporation. Mr. Nicholson seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said agreement is attached hereto and made a part of these minutes.

Mr. Kimmel made a motion to approve employee assistance program agreement with LifeSpring Health Systems, Inc. There were no changes from the 2021 agreement. Mrs. Sanders seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said agreement is attached hereto and made a part of these minutes.

Ir. Pittman made a motion to approve renewing property, casualty, and workman's comp insurance from ESCRFT. Mr. Nicholson seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No").

Mr. Hoke made a motion to approve Resolution to transfer \$350,000.00 from the Operations Fund to the Rainy Day Fund. Mr. Starr seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said Resolution is attached hereto and made a part of these minutes.

Mr. Kimmel made a motion to approve making necessary transfers of appropriations in the 2021 Education Fund Budget and 2021 Operations Fund Budget. Mrs. Sanders seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No").

A combined quote in the amount of \$32,855.00 was received from Lawrence County Equipment for a Kubota tractor with FE loader, bucket and snow plow; and Kubota utility vehicle with a diesel engine. Mr. Starr made a motion to approve the combined quote in the amount of \$32,855.00 from Lawrence County Equipment for a Kubota tractor with FE loader, bucket and snow plow and Kubota utility vehicle with a diesel engine to be paid from Operations Fund. Mr. Hoke seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No"). A copy of said quote is attached hereto made a part of these minutes.

Mr. Walker informed the Board that on November 23, 2021, he accepted <u>Mary McFarland's</u> resignation as custodian at Throop Elementary, effective November 17, 2021.

Mr. Walker informed the Board that on December 8, 2021, he accepted <u>Geneva Nelson's</u> resignation as asstructional assistant at Paoli Jr.-Sr. High School, effective December 21, 2021.

Mr. Walker informed the Board that on December 8, 2021, he accepted <u>Barbara Rutherford's</u> resignation as High Ability Coordinator for Paoli Community School Corporation, effective at the end of the first semester, December 21, 2021.

Mr. Starr made a motion to approve employing Mariah Dunn-Buchanan as 8th grade English teacher at Paoli Jr.-Sr. High School for the 2021-2022 school year for a 123 day contract at the salary of \$26,594.36, effective November 4, 2021; Karey Baker as ISS supervisor at Throop Elementary for 5.5 hours per day at the rate of \$12.25 per hour, effective January 3, 2022; increasing Katie Dillard .75 hours per day for morning traffic duties at a rate of \$11.50 per hour to be paid from ESSER III, effective November 23, 2021; paying Skyler Busick a stipend of \$1,125.00 plus FICA and TRF as the corporation High Ability Coordinator for the remainder of the 2021-2022 school year to be paid from the High Ability Grant, effective January 3, 2022; Harley Bush as an instructional assistant Throop Elementary for 5.25 hours per day at the rate of \$12.25 per hour, effective January 3, 2022; Jami Smith as day-shift custodian at Paoli Jr.-Sr. High School at the rate of \$10.75 per hour for 8 hours per day with benefits to be paid from remaining funds from CARES Act and then to be paid from ESSER II, effective December 14, 2021; and Mackenzie King as a WIN instructional assistant for 7 hours per day at the rate of \$12.25 per hour to be paid from ESSER II, effective December 6, 2021. Mr. Walker shared the 1782 Notice, which sets the school's 2022 property tax rate at \$1.0082. (0.3259 for debt service and 0.6823 for operations)

Mr. Nicholson made a motion to approve the pilot of Readable English Student Licenses and Professional Development to be paid out of ESSER III funds. Mr. Hoke seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No").

Mrs. Tucker recognized Mr. Walker for being named the 2021 Indiana Region 9 ASBO School Business Official of the Year.

Mr. Kimmel made a motion to adjourn. Mr. Hoke seconded the motion. All voted in the affirmative. The motion passed (7 "Yes", 0 "No).

2. Transition of Residential District Representation - The representation of the existing residential districts shall be transitioned under this proposed plan change in the following manner:

a) In the November, 2022, general election, the terms of members Lila Tucker (current District One); Doug Pittman (current District Two); and Bill Hoke (current District Three) would end at the year end and their replacements would run as candidates to be voted on by all eligible voters in the PCSC. Each of the elected replacement candidates would commence his/her term of office as of January 1, 2023, and those terms would end as of the December 31, 2026.
