Indiana Assessment System

The Indiana assessment system was recently released for vendors to submit a Request for Proposal (RFP) for one or more of the assessment components. The RFP assessment components are aligned to the Education Roundtable Resolution adopted June 23, 2014 and subsequently adopted by the State Board of Education on July 9, 2014.

There were a total of 7 components for the Indiana assessment system that fulfilled the expectations of the assessment resolutions:

- three of the components are federal and state requirements, such as a summative assessment;
- two components are state required, such as a reading assessment at grade 3, currently IREAD-3; and Accuplacer at grade 11 and
- other components were potential assessments, but not required, such as formative assessments.

We have a unique opportunity to build an affordable and streamlined Indiana assessment system that best meets the needs of our Indiana students, educators, taxpayers and families.

Therefore, the Indiana Department of Education (IDOE) has released the attached chart which is a comprehensive list of required and optional assessment options. The IDOE-recommended components are in alignment with the following values of an assessment system:

An assessment system must provide:

- ongoing formative feedback to educators in English language arts and mathematics in grades 3-10;
- the reporting of independent reading data to inform instruction and learning through the formative and summative assessments in all grade levels 3-10. This data would be separate from the ELA score that is required for state and federal accountability. This would be done without adding assessment time or cost;
- feedback for learning in all grade levels 3-10 (grades 3-8 and 10 are federally required; adding grade 9 provides for continuous growth to be measured at the high school level for the first time towards college and career readiness and aligns to the new Indiana accountability model); and
- fulfillment of all federal assessment requirements, enabling Indiana to maintain the federal ESEA flexibility waiver for some of the requirements from No Child Left Behind (NCLB).
- providing for alternative assessments for populations of students with unique learning needs.

You will see in the highlighted IDOE column on the right side of the chart the assessments for which the Department will be advocating.

RE: ISTEP+ Remediation and Preventive Remediation Distribution

DATE: March 24, 2015

Indiana Code 20-32-8-5 provides that the State Board of Education and the State Budget Agency shall approve, and the State Budget Committee shall review, the ISTEP+ Remediation and Preventive Remediation Grant formula.

The law requires that remediation funds be allocated among school corporations and charter schools on the basis of the percentage of students who do not achieve a passing score on ISTEP+. Students whose ISTEP+ scores are farthest below the passing score have generated the largest per pupil per subject amount. The proposed distribution formula for English/Language Arts, Mathematics, Science and Social Studies includes three tiers. Students who score at or above the passing score do not generate funds.

We respectfully request approval of one distribution in calendar year 2015. The distribution will be made this spring and, given full participation by school corporations and charter schools, will total \$3,000,163.05. Per pupil funding at Tier 1 is \$19.08; at Tier 2 is \$9.54; and at Tier 3 is \$4.77. The distribution is based on the spring 2014 administration of ISTEP+. Thank you for your consideration.

The Department has prepared the distribution of Graduation Qualifying Examination (GQE) Remediation Grant funds. Statute requires that the State Board of Education and the State Budget Agency shall approve, and the State Budget Committee shall review, the GQE Remediation Grant formula.

The GQE Remediation Grant distribution for school corporations and charter schools is based on the administration of GQE End of Course Assessments (ECAs) during the 2013-2014 school year. The grant funds remediation for students who did not pass the Algebra I and/or English 10 ECAs. The formula distributes \$148.38 per content area for each first time test-taker that did not pass the Algebra I and/or English 10 ECAs.

We respectfully request approval of one distribution in calendar year 2015. The distribution will be made this spring and, given full participation by school corporations and charter schools, will total \$4,959,007.98, which is \$184.20 more than the 2014 distribution.
