**RE:** Approval of Governing Body Change—Richmond Community Schools

STAFF RECOMMENDATION: After review of the materials provided by Richmond Community Schools ("Richmond"), it is evident that 1) the governing body resolution was properly approved by Richmond, 2) the resolution was properly published in a local newspaper, and 3) the county clerk certified that no protest petitions or alternative plan amendments were submitted to the clerk's office. Furthermore, the plan amendment satisfies the applicable legal requirements under Indiana Code and is recommended for Indiana State Board of Education ("Board") approval pursuant to I.C. 20-23-8-15.

Pursuant to IC 20-23-8-10(a)(2), Richmond adopted a resolution to initiate a plan to change its governing body in July of 2019. Subsequent to Richmond adopting the resolution to amend its governing body, it submitted the attached materials for the Board's review and consideration. The materials included the prior governing body plan, the resolution adopted by Richmond, the minutes from Richmond's board meeting during which the resolution was adopted, the local publication information that includes the language of the new governing body plan, and the county clerk's certification that no protest petitions or alternative plan amendments were submitted to the clerk's office. The governing body resolution allows for a slight revision to the existing residential district boundaries to create more uniform district lines. The proposed amendment reads:

#### Plan for Governing Body Residential Boundaries Change

- A. Board of School Trustees (only change from 2011 Plan Change is in the descriptions of Districts 1 and 2)
  - Number & Residential Districts The governance of RCS shall be vested in a non-partisan Board composed of seven (7) members elected at a November general election in accordance with the provisions of IC 20-23-4-29 and of IC 3-8-2-4. There shall be created three (3) geographically defined and limited residential districts from which one (1) member residing therein shall be elected to the RCS governing body (thereby comprising a total of three (3) resident members) and an "at large" district comprised of the entire geographical area of the RCS school district from which a total of four (4) members shall be elected. Residential districts are as follows:
    - a. District #1 (See attached Schedule #1) (changed)
    - b. District #2 (See attached Schedule #2) (changed)
    - c. District #3 (See attached Schedule #3) (no change)

- Term of Office (no change from 2011 Plan Change) Membership on the RCS Board shall constitute the holding of a "lucrative office" as said term is used in Article 2, §9, of the Constitution of the State of Indiana. Members shall be elected to a term of office of four (4) years commencing as of January 1 of the year following the year of their election, except as otherwise herein provided.
- 3. Organization and Appointment of Officers (no change from 2011 Plan Change) The Board shall annually organize within fifteen (15) days after the commencement date of the members' terms of office, or within such time as might otherwise be required by applicable law. The Board shall select from among its membership a president, vice president and secretary, each of whom shall be a different member of the Board. The Board may make such other appointments as permitted by, and in accordance with, applicable law.
- Compensation (no change from 2011 Plan Change) Members shall be entitled to compensation for the performance of their duties on the Board, as limited by applicable law and as determined, from time to time, by resolution of the Board.
- Eligibility for Membership on Board (no change from 2011 Plan Change) - To be eligible to serve on the Board, a candidate for election to the Board must have attained the age of twenty-one (21) years prior to the date that the candidate's term of office would begin.

Candidates running for election to the Board from one of the three geographically limited and defined residential districts must have been a continuous resident of that residential district for a period of time in excess of one (1) year prior to the date of the general election on which the candidate's name appears on the ballot for election to the Board. Property ownership shall not be an eligibility requirement for a candidate seeking election to the Board.

6. Vacancies on Board (no change from 2011 Plan Change) – Vacancies on the Board existing because of the death of a school board member shall be filled in the manner provided by IC 20-26-4-4.5, as from time to time amended. Vacancies on the Board existing for any reason other than the death of an elected, qualified and acting school board member shall be filled in the manner provided by IC 20-26-4-4, as from time to time amended.

- B. <u>Transition Plan Pending Board Elections</u> No currently elected, qualified and sitting members of the RCS Board are impacted by the proposed change in the residential boundaries of residential Districts I and 2 so there is no need for a transition plan attendant to the current proposed change in the RCS Organizational Plan.
- C. Election Date for Board Members under Proposed Plan Change Upon passage of this proposed plan change and its becoming effective upon the Effective Date, the newly defined boundaries of residential Districts 1 and 2 shall apply for those candidates to the Board running in the November, 2020, general election in residential Districts 1 or 2.

#### D. Retention of Terms of Originally Adopted Plan of Organization as Modified by the 2011 Plan Change

Except as specifically modified herein in those particulars related only to the proposed change in the boundaries of residential Districts 1 and 2, all other terms and conditions of the original RCS Plan of Reorganization, as approved by the Indiana State Commission on School Reorganization on or about November 17, 1961, and as ratified by the voters of the newly created RCS school district at a primary election held May 8, 1962 and as thereafter modified by the 2011 Plan Change, shall remain fully effective.

#### E. Effective Date

This proposed plan change shall become effective the later of the date of approval of this change and its certification by the Indiana State Board of Education or August 1, 2020.

Dear Mr. Schultz:

You will recall that this office is general counsel to Richmond Community Schools ("RCS"), that is entirely located in within the geographical boundaries of Wayne County, Indiana. The RCS Board of School Trustees ("Board") proposes to change its organizational plan by modifying the geographic boundaries of two of the three residential districts from which board members are elected in order to square the boundaries of those two districts that were created by the 2011 Plan Change. Included herewith please find the following:

- Tab A Behind Tab A you will find excerpts from the minutes of a regular meeting of the RCS Board held July 24, 2019, whereat it passed a resolution initiating the plan change.
- **Tab B** Behind Tab B you will find a copy of the executed Resolution referenced in the minute excerpts behind Tab A.
- Tab C Behind Tab C you will find a copy of the Public Notice of the Adoption of a Resolution Initiating an Amended and Restated Plan of Organization Changing Only Two of Three Residential Districts Boundaries of Candidates for Election to Governing Body (the "Amended Plan"). That document sets forth the text of the Amended Plan and has the schedules that identify the newly to-becreated residential district boundaries for District #1 and District #2. If approved prior to the date for the filing of candidacy for election to the RCS governing

body at the November, 2020, General Election, there would be no impact on any current member of the Board; none of the terms of office of the current Board would be affected by the Amended Plan; therefor, no transition plan is believed to be necessary to implement the Amended Plan.

- **Tab D** Behind Tab D is the publisher's affidavit verifying the July 31, 2019, publication of the Public Notice of the Board's passage of its July 24, 2019, resolution initiating the proposed Amended Plan.
- Tab E Behind Tab E is the original executed Clark's Certificate issued by the Clerk of the Wayne Circuit Court attesting to the fact that no petitions protesting the Board's proposed Amended Plan had been filed by the deadline of November 28, 2019, nor had any alternative plans been proposed during said period or from said date through the date of execution by the said clerk of the foregoing certificate.
- Tab F Behind Tab F are the documents that evidence the historical development of the current RCS Plan of Organization. The first document (behind Tab F-1) is an excerpt from the Comprehensive Plan for the Reorganization of the School Corporations of Wayne County, Indiana that was prepared by the Wayne County Committee for the Reorganization of School Corporations and submitted to the State Commission for the Reorganization of School Corporations on September 5, 1961. The original RCS plan provided for a seven member elected governing body with four (4) members of that governing body elected "at large" and with three (3) members of that governing body elected (one each) from three (3) residential districts wherein each elected member of said district had to have been a resident. All members, both at-large members and residential district members were voted upon by all eligible voters within the RCS district. That original plan was first amended in 2011 (the "2011 Plan") (behind Tab F-2) to redefine the geographical territories comprising each of the three (3) residential districts due to historical problems in having candidates file from one (1) of the three (3) originally created residential districts. At the time of filing the 2011 Plan, it was necessary to create a small approximately five (5) by one (1) city block appendage as part of the then newly defined District #1 in order to avoid displacing a then-sitting member of the governing body. Since adoption of the 2011 Plan, that former sitting member is no longer a member of the RCS governing body. The current RCS Board desires to eliminate that carved out appendage of District #1 and make linear the boundary that will separate the newly defined Districts #1 and #2, as set forth in the Amended Plan submitted herewith.

At this point RCS, its Board and administration, are respectfully presenting these materials in support of its proposed Amended and Restated Plan of Organization. We ask that the State Board of Education review these materials and issue its order approving the Amended Plan. Toward that end, if there is additional information that this office can provide, please do not hesitate to contact me.

Attorney Ron Cross presented a resolution that he had prepared to initiate the change in the organization plan of the school corporation, pursuant to Indiana Code (IC) 20-23-8, et. seq., that had been discussed by the board at several previous meetings. After a thorough discussion of the terms of proposed change in the RCS organizational plan, upon motion by Member Morey, seconded by Member Derengowski, the following resolution was unanimously adopted by a vote of seven (7) ayes; zero (0) nays:

Part of Wayne Township, Wayne County, Indiana, described as follows:

Parts of Wayne and Boston Townships, Wayne County, Indiana, described as follows:

Beginning at the SE corner of Boston Township which is identified as the SE corner of Sec 1, Township 12 North, Range 1 West; thence in a northerly direction along the Boston Township line and continued along the Wayne Township line to the centerline of US 40 (National Rd); thence in a westerly direction along the centerline of US 40 (National Rd) and continued along the centerline of Main Street to the intersection of 9<sup>th</sup> Street; thence in a southerly direction along the centerline of South 9<sup>th</sup> Street to where it merges into US 27 S; thence in a southerly direction along the centerline of US 27 S to the Wayne County and Union County line, which is also the SW corner of Boston township identified as the SW corner of Sec 6, Township 12 North, Range 1 West; thence in an easterly direction along the Boston Township line to the place of beginning.





#### IN MEMORIUM

The sudden death of Superintendent of Schools Victor C. Scott on Saturday, the 27th day of February, 1960, came as a tragic shock to his countless friends throughout the land. During his many years of dedicated service to public education in Wayne County, Mr. Scott had established himself as one of our communities' great educational leaders.

Death claimed Victor Scott at a time when he was engaged in the most important task of his career - a task that, ironically enough, was destined to dispense with the very office he had filled so capably for the past three years. Since August, 1959, the late Mr. Scott had worked wholeheartedly for the intelligent re-organization of our county's schools. Even before the Wayne County Committee for the Re-organization of School Corporations had been legally appointed, he attempted to make budgetary provisions for funds for the Committee so that their work might not be delayed. Once the Committee had started its work, Mr. Scott made available all of the facilities and information at his command, and accepted a major share of the responsibility for collecting the vast amount of data needed before logical deliberations could begin. While continuing consistently the regular duties of his office, Mr. Scott devoted numerous days and hours of the last six months of his life working for school re-organization - working for a change in the Wayne County educational system that would bring himself a personal loss, but one that would improve the educational opportunities for all.

The work of the Wayne County Re-organization Committee will be completed only when provisions have been made for better educational opportunities for the children of Wayne County. The important contribution that Victor Scott made to the work of this Committee will stand forever as a true measure of his devotion to education and to educational progress.

#### PROPOSED SCHOOL REORGANIZATION PLAN

The Wayne County Committee for the Reorganization of School Corporations has adopted a five-unit plan of reorganization for the county. The basic information relative to each proposed unit will be presented as new community school corporation is described.

#### Proposed Community School Corporations

- I. RICHMOND COMMUNITY SCHOOLS
- II. THE CENTER\_ABINGTON COMMUNITY SCHOOLS
- III. WESTERN WAYNE SCHOOLS
- IV. NETTLE CREEK SCHOOL CORPORATION
  - A. <u>Boundaries</u> The boundaries of the Nettle Creek School Corporation shall include the existing boundaries of Jefferson, Dalton, Perry, Clay and Harrison Townships.
  - B. Board of School Trustees
    - Number The control of the Nettle Creek School Corporation shall be vested in a board of school trustees composed of seven (7) members elected on a non-political ticket according to the provisions of Section 9, Chapter 202, of the Acts of 1959.
      - a. There shall be created six (6) school board member residence districts as follows:
        - District A Jefferson Township including the civil town of Hagerstown,
        - 2. District B Dalton Township,
        - 3. District C Perry Township,
        - 4. District D Clay Township,
        - 5. District E .- Harrison Township,
        - District F An "at large" district including the entire Nettle Creek School Corporation.
  - C. Method of Selection and Term of Office

    The Nettle Creek School Corporation shall have an elected board of

# seven (7) members as follows:

One (1) member shall be a resident of District A, One (1) member shall be a resident of District B. One (1) member shall be a resident of District C. One (1) member shall be a resident of District D. One (1) member shall be a resident of District E. Two (2) members shall be residents of District F.

Candidates for membership on the board of school trustees shall compete against one another for election of a school board member residence district basis as specified in the sections on limitations on residence, term of office and other qualifications required of the members of such board of school trustees, but they shall be voted upon by the voters residing within the boundaries of the school corporation.

At the first general election following the creation of the Nettle Creek School Corporation, the four (4) elected members receiving the highest number of votes shall be elected for a term of four (4) years. The three (3) other elected members shall be elected for a term of two (2) years. All board members shall take office and assume their duties on the first day of July after their election except the term of the elected member receiving the highest number of votes at the first election shall be extended for one(1) year. Thereafter, all members shall be elected for four (4) year terms of office, said election to be held at the primary election immediately preceding the expiration of the terms of office in question, to take office at the expiration of said term.

# D. Interim Board of School Trustees

The interim board of school trustees shall be selected in the manner described below without regard to political party affiliation. The interim board shall serve until their successors are duly elected at the general election as described above.

The board of school trustees currently serving the Hagerstown-Jefferson Township School Corporation shall appoint from their number or otherwise, three (3) members of the interim board from District A, Jefferson Township including the civil town of Hagerstown.

The Township Trustee and Advisory Board of Dalton Township shall appoint one (1) member of the interim board from District B, Dalton Township.

The Township Trustee and Advisory Board of Perry Township shall appoint one member of the interim board from District C. Perry Township.

The Township Trustee and Advisory Board of Clay Township shall appoint one (1) member of the interim board from District D. Glay Township.

The Township Trustee and Advisory Board of Harrison Township shall appoint one (1) member of the interim board from District E. Harrison Township.

No later than thirty (30) days prior to the creation of the community school corporation it shall be the duty and responsibility of the Wayne County Superintendent of Schools to notify the president and members of the Hagerstown-Jefferson Township School Corporation board of school trustees and the township trustees and advisory boards of Dalton, Perry, Clay and Harrison Townships of their respective responsibilities in the appointment of school board of trustee member(s) as provided herein to serve on the interim board for the new community school corporation. If, for any reason, members of the interim board of school trustees have not been appointed in accordance with the procedures described above ten (10) days prior to the date on which the community school corporation shall legally come into being, then it shall be the duty and responsibility of the Judge of the Circuit Court to make such appointments as are necessary to complete the membership of the interim board of school trustees from the school board residence districts as described.

#### E. Officers

Officers of the board of school trustees shall be president, vicepresident, secretary and treasurer. The board shall organize annually within three (3) days after July 1.

### F. Rights, Powers and Duties of the Board of School Trustees

The control and administration of the Nettle Creek School Corporation shall be vested in a board of school trustees whose rights, powers and duties shall be those of a board of school trustees of a city of the fifth (5th) class.

#### G. Qualifications of School Board Members

To be eligible to be elected to serve on the board of school trustees of Nettle Greek School Corporation the candidate must be not less than twenty-one (21) years of age and be a legal resident of the school board member residence district from which he is to be elected. If, after being elected to serve on the board of school trustees, a member moves his legal residence outside the boundaries of the community school corporation, he ceases to be a member of said board and a vacancy on the board shall be declared.

#### H. Vacancies on the Board of School Trustees

If at any time there should occur a vacancy on the board of school

trustees for any reason, the remaining members of the board of school trustees, whether or not a mejority of the board, shall by a majority vote, fill such vacancies by appointing a person or persons to serve for the term or belance of terms respectively. In the event of a tie vote among the remaining members of the board of school trustees, or their failure to act within thirty (30) days after any such vacancy occurs, it shall be the duty of the Judge of the Circuit Court to make such appointment.

### I. Compensation for Members of Board of School Trustees

Board members shall receive compensation not to exceed two hundred dollars (\$200,00) per year.

#### J. Disposition of Assets and Liabilities

At the time it comes into being, the Nettle Creek School Corporation will assume all of the assets and all the liabilities of the school corporation preceding it, namely; the Hagerstown-Jefferson Township School Corporation,

Dalton School Township, Perry School Township, Clay School Township, and Harrison School Township.

The Nettle Creek School Corporation shall assume, at the time it comes into being, the financial obligations for all school aid bonds outstanding and existing, if any, of Jefferson Township, Dalton Township, Perry Township, Clay Township, Harrison Township and of the civil town of Hagerstown in accordance with Chapter 202, Acts of 1959 of the General Assembly as amended by Chapter 322 of the Acts of 1961. The proposed community school corporation shall make payments to the civil governmental units, if any, that have heretofore issued school aid bonds in an amount sufficient to make interest payments and to retire principal according to schedule. However, the Nettle Creek School Corporation shall not assume the financial obligations of the various civil governmental units for school aid bonds issued after July 1, 1961.

#### Plan for Governing Body Composition Change

#### A. Board of School Trustees

- 1. Number & Residential Districts The governance of RCS shall be vested in a non-partisan Board composed of seven (7) members elected at a November general election in accordance with the provisions of IC 20-23-4-29 and of IC 3-8-2-4. There shall be created three (3) geographically defined and limited residential districts from which one (1) member residing therein shall be elected to the RCS governing body (thereby comprising a total of three (3) resident members) and an "at large" district comprised of the entire geographical area of the RCS school district from which a total of four (4) members shall be elected. Residential districts are as follows:
  - a. District #1 (See attached Schedule #1)
  - b. District #2 (See attached Schedule #2)
  - c. District #3 (See attached Schedule #3)
- 2. Term of Office Membership on the RCS Board shall constitute the holding of a "lucrative office" as said term is used in Article 2, §9, of the Constitution of the State of Indiana. Members shall be elected to a term of office of four (4) years commencing as of January 1 of the year following the year of their election, except as otherwise herein provided.
- 3. Organization and Appointment of Officers The Board shall annually organize within fifteen (15) days after the commencement date of the members' terms of office, or within such time as might otherwise be required by applicable law. The Board shall select from among its membership a president, vice president and secretary, each of whom shall be a different member of the Board. The Board may make such other appointments as permitted by, and in accordance with, applicable law.
- 4. <u>Compensation</u> Members shall be entitled to compensation for the performance of their duties on the Board, as limited by applicable law and as determined, from time to time, by resolution of the Board.
- 5. Eligibility for Membership on Board To be eligible to serve on the Board, a candidate for election to the Board must have attained the age of twenty-one (21) years prior to the date that the candidate's term of office would begin. Candidates running for election to the Board from one of the three geographically limited and defined residential districts must have been a continuous resident of that residential district for a period of time in excess of one (1) year prior to the date of the general

- election on which the candidate's name appears on the ballot for election to the Board. Property ownership shall not be an eligibility requirement for a candidate seeking election to the Board.
- 6. Vacancies on Board Vacancies on the Board existing because of the death of a school board member shall be filled in the manner provided by IC 20-26-4-4.5, as from time to time amended. Vacancies on the Board existing for any reason other than the death of an elected, qualified and acting school board member shall be filled in the manner provided by IC 20-26-4-4(c), as from time to time amended.

#### B. Transition Plan Pending Board Elections

1. <u>Schedule of Current Board Terms</u> – The terms of office of the current members of the Board, their last election dates, their next election dates and the dates of seating following their next election under the existing RCS governing body selection plan are as follows:

2. Extension of Existing Terms of Office – The existing terms of office of all members of the Board except Member Stidham (current Residential District "C") shall be extended for a period of six (6) months through year end of the year in which each member's current term is due to expire. If this proposed *Plan for Governing Body Composition Change* shall not have become effective by June 30, 2011, then the term of Member Stidham shall extend until the earlier of the Effective Date of this proposed plan change or December 31, 2011.

- 3. <u>Transition of Residential District Representation</u> The representation of the existing residential districts shall be transitioned under this proposed plan change in the following manner:
  - a. Member Morgason currently resides in and represents Residential District "A". Her residence will be within the geographically defined and limited Residential District #1 under this proposed plan. From the Effective Date of this proposed plan until the end of her present term, as herein extended, Member Morgason shall be the Board member from newly defined Residential District #1.
  - b. Member Baumgartner currently resides in and represents Residential District "B". Her residence will be within the geographically defined and limited Residential District #2 under this proposed plan. From the Effective Date of this proposed plan until the end of her present term, as herein extended, Member Baumgartner shall be the Board member from newly defined Residential District #2.
  - c. Upon the end of Member Stidham's term, as potentially extended hereunder, but in any event not later than December 31, 2011, the vacancy created by the expiration of his term shall be filled by the majority vote of the remaining members of the Board, in accordance with the provisions of IC 20-26-4-4(c), by appointing a person to the Board who meets all other applicable eligibility criteria and also meets the herein stated residency requirements for the newly created Residential District #3. That appointee shall serve an abbreviated term beginning from the date of his/her appointment and qualification and ending December 31, 2014. The Residential District #3 Board member shall first stand for election in the general election in November 2014, to be seated as of January 1, 2015.
- 4. Election Date for Board Members under Proposed Plan Change Upon passage of this proposed plan change and its becoming effective upon the Effective Date, all members of the Board will be elected at general elections held in November of the appropriate years. The current Board membership positions will be elected in accordance with the following schedule.

Except as specifically modified herein in those particulars including the manner and time of their election, their residency, transitional terms of office and time of election of the members of the Board, as set forth herein, all other terms and conditions of the original RCS Plan of Reorganization, as approved by the Indiana State Commission on School Reorganization on or about November 17, 1961, and as ratified by the voters of the newly created RCS school district at a primary election held May 8, 1962 shall remain fully effective after the Effective Date hereof.

#### D. Effective Date

The terms and conditions related to the appointment of a Board member from the newly defined Residential District #3, as set forth more particularly at §3c, above, shall become effective upon adoption of this plan, as provided at IC 20-23-8-19. All other aspects of this proposed plan change shall become effective as of January 01, 2012.
