RE: Approval of Governing Body Change—Edinburgh Community School Corporation

STAFF RECOMMENDATION: After review of the materials provided by Edinburgh Community School Corporation (“Edinburgh”), it is evident that 1) the governing body resolution was properly approved by Edinburgh, 2) the resolution was properly published in a local newspaper, and 3) the county clerk certified that no protest petitions or alternative plan amendments were submitted to the clerk’s office. Furthermore, the plan amendment satisfies the applicable legal requirements under Indiana Code and is recommended for Indiana State Board of Education (“Board”) approval pursuant to I.C. 20-23-8-15.

Pursuant to IC 20-23-8-10(a)(2), Edinburgh adopted a resolution to initiate a plan to change its governing body in February of 2019. Subsequent to Edinburgh adopting the resolution to amend its governing body, it submitted the attached materials for the Board’s review and consideration. The materials included the prior governing body plan, the resolution adopted by Edinburgh, the minutes from Edinburgh’s board meeting during which the resolution was adopted, the local publication information that includes the language of the new governing body plan, and the county clerk’s certification that no protest petitions or alternative plan amendments were submitted to the clerk’s office. The governing body resolution seeks to amend the method by which the members of the Board of School Trustees of the Edinburgh Community School Corporation are selected to serve. The proposed amendment reads:

WHEREAS, the Board of School Trustees of the Edinburgh Community School Corporation seeks to amend the Governing Body Selection Plan of the Johnson County Reorganization Plan of 1972:

NOW, THEREFORE, BE IT RESOLVED by the Board the Governing Body Selection Plan shall read as follows:

The Edinburgh Community School Corporation consists of the entirety of Blue River Township including the Town of Edinburgh, and a portion of German Township, Bartholomew County, annexed to the Town of Edinburgh.

The Board of School Trustees shall consist of five (5) members. All five (5) members shall file and be elected as candidates at large. Each member shall be a registered voter, a high school graduate, and shall have resided in the Edinburgh Community School Corporation district at least one (1) year at the time of election. Residence is interpreted to mean having physically moved into a home in the district.

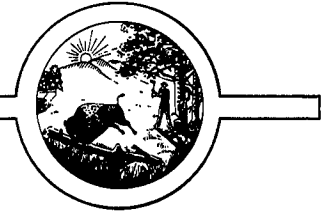
The method of election shall be on a non-partisan basis, by popular election, at the time of the regular general election. The members elected from the district shall be the five (5) candidates receiving the greatest number of votes from among those designated, and running as at large candidates. In case of a tie vote, the decision among those tied shall be made under the supervision of the Judge of the Johnson County Circuit Court by "casting lots".

Members shall serve staggered terms with three (3) members elected during a November regular general election and two (2) members elected during the November regular general election two (2) years later.

The term of office for all members shall be four (4) years.

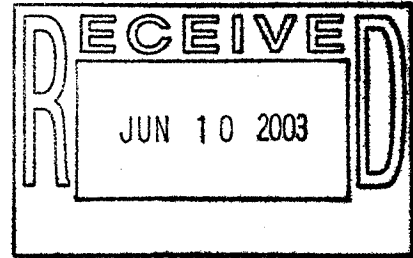

The Board of School Trustees shall meet and organize within the first fifteen (15) days of January of each calendar year, at which time newly-elected members shall present their certificate of election and take their oath of office.


I visited the State Archives this morning and was able to obtain the enclosed documents. The approved reorganization plan for Johnson County and specifically the Edinburgh Community School Corporation called for a five (5) member school board (two members from Edinburgh, two from Blue River Township, and one member at-large), elected at the general election but with staggered terms (3/2).

There are certain elements of the governing body selection plan that are no longer permissible by statute. Of special note would be IC 3-8-1-34 (length of residency in a school corporation prior to election) and IC 20-5-3-10 (prohibiting property ownership as a qualification to be a board member).

The archival records do not indicate this governing body selection plan has been amended since its inception.

Should you require anything additional, please advise.

NOW, THEREFORE, BE IT RESOLVED by the Board the Governing Body Selection Plan shall read as follows:

The Edinburgh Community School Corporation consists of the entirety of Blue River Township including the Town of Edinburgh, and a portion of German Township, Bartholomew County, annexed to the Town of Edinburgh.

The Board of School Trustees shall consist of five (5) members. Two (2) members shall be elected from the district comprising the Town of Edinburgh, two (2) members shall be elected from the district comprising Blue River Township, not including the Town of Edinburgh, and one (1) member shall file and be elected as candidate at large. Each member shall be a registered voter, a high school graduate, and shall have resided in his/her district at least one (1) year at the time of election. Residence is interpreted to mean having physically moved into a home in the district.

The method of election shall be on a non-partisan basis, by popular election, at the time of the regular general election. The members elected from each of the two (2) board member districts shall be the two (2) candidates from each district receiving the greatest number of votes. The member elected at large shall be the one receiving the greatest number of votes from among those designated, and running as at large candidates. In case of a tie vote in any of the five contests, the decision among those tied shall be made under the supervision of the Judge of the Johnson County Circuit Court by "casting lots".

Members shall serve staggered terms with three (3) members elected during a November regular general election and two (2) members elected during the November regular general election two (2) years later. The three (3) member election year shall include two (2) Blue River Township, not including the Town of Edinburgh, members, and the at large member. The two (2) member election year shall include two Town of Edinburgh members.


The term of office for all members shall be four (4) years. In case an elected member moves his residence outside the district from which he/she is elected, but remains a resident of the school corporation, it shall not disqualify him/her from completing the term on the Board of School Trustees.


The officers of the Board of School Trustees shall be President, Vice President, and Secretary. The Board of School Trustees shall meet and organize within the first fifteen (15) days of January of each calendar year, at which time newly-elected members shall present their certificate of election and take their oath of office.

Pay for elected board members shall be set annually.







Notice to the Voters of the enrollment area of the Edinburgh Community School Corporation:

The Edinburgh Board of School Trustees approved the following update to their Governing Body Selection Plan on July 21, 2003. This update represents the plan currently followed by the Board, however, this plan had not been taken through the official process required by the Indiana Board of Education. This process is defined by IC20-4-10.1-5 through 10.1-8.

After approval of the plan, the Board must publish a notice in a local newspaper. Voters have the right to file a petition protesting the plan. This petition must include 500 signatures or 20% of the voters of the school corporation whichever is less. It must be presented to the clerk of the circuit court within 120 days after this publication date. Within 30 days after the expiration of the petition filing period, the clerk will inform the school corporation if a petition has been filed. The plan and any petitions that have been filed are sent to the Indiana State Board of Education for determination.



The Board of School Trustees met in regular session at 6:00 p.m. on this date at the Administration Building, 202 S. Keeley Street, Edinburgh, IN 46124 with Mr. Lollar presiding. Mrs. Hamm was absent.

Everyone was led in prayer by Mr. Teter and the Pledge of Allegiance by Mr. Lollar.

PRESENTATIONS

A. Building Reports

Mr. Scholl, East Side Elementary Principal, stated this past Friday, The National Association for Educational Progress sent representatives to assess 4th graders in reading and math. We, along with many other schools were randomly selected to participate in this assessment which measures academic progress in all 50 states. We also had an ensemble of girls in Lancerettes advanced to the state in choir. Girls in the ensemble are: Faith Totten, Katie Roberts, Clara Carman and Peyton McKay. Mr. Rockey thanked the EEA for providing pizza at their last staff meeting. Mr. Rockey stated the scheduling process is underway. Mrs. Foltz has met with every grade level as a group and she will then meet with

The Board of School Trustees shall consist of five (5) members. All five (5) members shall file and be elected as candidates at large. Each member shall be a registered voter, a high school graduate, and shall have resided in the Edinburgh Community School Corporation district at least one (1) year at the time of election. Residence is interpreted to mean having physically moved into a home in the district.

The method of election shall be on a non-partisan basis, by popular election, at the time of the regular general election. The members elected from the district shall be the five (5) candidates receiving the greatest number of votes from among those designated, and running as at large candidates. In case of a tie vote, the decision among those tied shall be made under the supervision of the Judge of the Johnson County Circuit Court by "casting lots".

Members shall serve staggered terms with three (3) members elected during a November regular general election and two (2) members elected during the November regular general election two (2) years later.

The term of office for all members shall be four (4) years.

The officers of the Board of School Trustees shall be President, Vice President, and Secretary. The Board of School Trustees shall meet and organize within the first fifteen (15) days of January of each calendar year, at which time newly-elected members shall present their certificate of election and take their oath of office.

Pay for elected board members shall be set annually.


