RE: Approval of Federal 1003 School Improvement Funding for Turnaround Academies

Recommendation: Direct the Indiana Department of Education ("Department") to set-aside approximately \$3.9 million in federal 1003 School Improvement funds to support Indiana State Board of Education ("Board") interventions at the State's thirteen (13) turnaround academies.

Background: Indiana Law requires the Board to determine the amount of state tuition support and federal funds that are necessary to fund options for improvement implemented by the state board under this chapter with respect to each turnaround academy.

State Funds: The Board has historically deferred to each corporation and the state's tuition support formula when determining the amount of state funds required to support a turnaround academy that is not operated by a special management team. During the 2019-2020 school year, the Board voted to end the interventions at each turnaround academy operated by a special management team. As a result, there is no recommendation pertaining to state tuition support to fund the remaining turnaround academies as the Board will continue to rely on the tuition support formula and provide each corporation discretion as to how they allocate state tuition support funds to support each intervention.

<u>Federal Funds</u>: The Board has historically directed federal 1003 school improvement funds to support each turnaround academy. In recent years these allocations have aligned to the multi-year budgets submitted along with the corporation's plan for intervention. The table included with this memo outlines the recommended amounts of federal 1003 school improvement funds needed to support the remaining Board interventions.

Analysis: This joint recommendation reflects an agreed upon amount of federal 1003 school improvement funds required to support State Board of Education interventions.

Overall allocation for turnaround academies reduced 43% or \$2.9M. The overall reduction for the upcoming school year is a result of the gradual reduction of funding for each turnaround academy and the termination of the four (4) interventions at turnaround academies operated by a special management team. Additionally, due to the hold harmless legislation passed by the General Assembly no new turnaround academies were identified following the 2018-2019 school year. It is the opinion of Board and Department staff that the recommended amount of \$3.9 million is sufficient to support each intervention at the remaining turnaround academies.

Adjustments were made to some allocations due to carry-over funds, adjustments to an intervention, and gradual reductions in funding from year to year. The table included with this memo provides details related to the amount of federal 1003 school improvement funds set aside for each intervention. Where applicable, footnotes explain additional reductions or increases to the total allocation for a given intervention.

¹ Funding for the Indianapolis Public Schools Transformation Zone reflects a pro rata reduction based on total enrollment as a result of Louis B Russel Elementary School being removed from the intervention. The governing board of the corporation voted this spring to transition Louis B Russel into an innovation network school in partnership with an external operator.

² The approved plan for the Kokomo Transformation Zone originally included an additional increase in total funding for the second year of implementation. This additional increase conflicts with the Board's practice of gradually reducing funding for each intervention over time. As a result, the Board calculated a 15% reduction from the previous year's total award to determine a revised award amount for 2020-2021. Additionally, Kokomo carried over \$259,752 from the 2018/2019 school year as a result in the delay in funding related to the ESSA transition. Those funds have been incorporated into the available funding for 2020-2021 which further reduced the awarded amount for the upcoming year.

³ The approved South Bend Empowerment Zone plan originally included a significant reduction between year 1 and year 2 (-41.5%) and was submitted prior to hiring the Zone Chief. As a result of unexpected legal costs associated with collective bargaining negotiations and an in-depth analysis of staffing and student needs, the Zone Chief requested to increase the award for 2020-2021. The requested amount reflects a 15% reduction from the previous year which falls within prior practice.

Per 1003(c) of ESSA, the max length of a 1003 subgrant shall be four years, in which a school would need to be CSI in order to be eligible for a second subgrant of one or more years. Schools that are no longer CSI after the end of a respective subgrant will be ineligible.

^{*} Indicates that a school is not currently a turnaround academy as defined by Indiana law; however, the school is included in a multi-school intervention that is strategically designed to improve educational opportunities at one or more turnaround academies.
