RE: Proposed Default Order - Cause No. 02-062021

Recommendation: Approve the proposed default order with respect to Cause No. 02-062021.

Background:

On April 5, 2021, the Metropolitan School District of Wabash County ("Petitioner") petitioned the Indiana State Board of Education ("Board") to hold an administrative hearing to determine whether School City of East Chicago ("Respondent") owed Petitioner \$10,626.56 for student transfer tuition from the 2019-2020 school year.

An administrative hearing was set for June 30, 2021, and on June 1, 2021, notice of the hearing was sent to both parties. Respondent failed to respond to the June 1st notice.

On June 30, 2021, the aforementioned administrative hearing was held. Petitioner attended the hearing via the teleconference line provided to both parties. Respondent failed to attend or participate in the hearing.

On June 30, 2021, a Notice of Proposed Default was sent to both parties. The Notice of Proposed Default gave Respondent seven (7) days to respond and to request that the Proposed Default Order not be imposed. Respondent failed to respond to the June 30th notice. To date, Respondent has yet to respond to notices or participate in the proceedings related to this matter.

Any party impacted by the proposed default order may attend the meeting on July 14, 2021, and directly address the Board members.
