Re: Common school loan policy

Date: March 26, 2020

In light of the national health emergency surrounding COVID-19, there are concerns that school corporations will not be able to spend loan proceeds within the time constraints specified in the State Board of Education's Administrative Policies for the Common School Fund. The policy, which was adopted June 7, 2017, provides the following deadlines for expenditure of loan proceeds:

- Construction advances must be used within two years after the State Board of Education approves the advance, with at least fifty percent of the advance used within one year after the State Board of Education approves the advance.
- Technology advances must be used within one year after the State Board of Education approves the advance.

With that, the Indiana Department of Education (IDOE) respectfully requests State Board of Education consideration of an amendment to the policy that extends the time frame for expenditures for any school corporation receiving a construction or technology loan in calendar year 2019. IDOE requests that a sixmonth extension to the current policies be allowed.

- Construction advances must be used within two years after the State Board of Education approves the advance, with at least fifty percent of the advance used within eighteen months after the State Board of Education approved the advance.
- Technology advances must be used within eighteen months after the State Board of Education approved the advance.

A modified time-frame allows school officials adequate time to complete projects in light of current events that may preclude them from normal activities.
