DATE: April 25, 2012

The Department has prepared the distribution of Graduation Qualifying Examination (GQE) Grant funds.

The GQE distribution is based on the administration of GQE End of Course Assessments (ECAs) from the 2010-2011 school year. The grant funds remediation for students who did not pass the Algebra I and/or English 10. The formula distributes \$119.09 per content area for each first time test taker that did not pass Algebra I and/or English 10.

If every school corporation and charter school participates the distribution will be \$4,958,907.60 which is \$2.40 less than the historical appropriation for this program (\$4,958,910).

We are asking for your review and approval of the GQE Remediation Grant.
