Liberty Christian High School has been accredited by the Association of Christian Schools International (ACSI) since 1988, Indiana State accredited through Freeway provisions since 2003, and a member of North Central Association (NCA) since 2006. Liberty Christian High school is also a member of the Indiana Non-Public Education Association (INPEA).
- Curriculum: Liberty Christian High School currently follows the Indiana Academic Standards in educating students. Liberty Christian High School desires to comply with the standards that Indiana chooses to endorse, whether they be Common Core or Indiana Academic Standards.
- Testing History: Liberty Christian ECA scores consistently exceed the state average. Under PL 221, the school earned an A in the last two years. *Sophomore and Junior students take the PSAT test each fall, and most juniors and seniors also take either or both the SAT and the ACT college entrance exams. In 2011 Liberty Christian High School students averaged a composite score of 23.8 on the ACT*




(nationwide composite average 21.1) and 1543 on the SAT (Indiana average 1469).

I. Identify the school entity to be declared a freeway school

Liberty Christian High School is a non-public, non-denominational 9th – 12th grade Christian school operated by Liberty Christian School, Inc. Liberty Christian High School opened in 1981 and graduated its first class in 1985. Liberty Christian High School currently has an enrollment of 156 in grades 9 – 12. Liberty Christian High School has been accredited by the Association of Christian Schools International (ACSI) since 1988, Indiana State accredited through Freeway provisions since 2003, and a member of North Central Association (NCA) since 2006. Liberty Christian High school is also a member of the Indiana Non-Public Education Association (INPEA).

Liberty Christian High School is located at 2323 Columbus Avenue, Anderson, Indiana, 46016, in the Washington Building. This facility is well maintained and is a former building of the Anderson Community Schools Corporation. It has 23 classrooms, a dedicated art room, computer lab, band room, learning resource lab, and a science lab. This 38,000 square foot facility also includes a gymnasium.

Liberty Christian High School is very involved in the community of Anderson and with the public schools in Madison County. Liberty students regularly volunteer as part of the school's curriculum and emphasis at various locations in the community and are involved in many different activities through such entities as Operation Love, the Christian Center, Lutheran Disabilities Ministry Camp, local co-ops, Rotary, IHSAA, local churches, blood drives, local nursing homes, Project Christmas Child, and local parks, and grounds.

Liberty Christian High School also partners with local public schools through IHSAA sports, fine arts programs and awards, cultural exchanges, co-op opportunities and some student services. The Liberty Christian High School Varsity Singers participate in the Festival of Trees singing competition with the public choirs, and they share their talents with many organizations in the community. Liberty Christian High School is also an I-20 school and encourages both cultural and ethnic diversity.

The mission, vision, and core values of Liberty Christian High School are as follows:

Mission: Liberty Christian School is a Christ-centered community where students receive an excellent education based on biblical truth.

Vision: Liberty Christian School will equip every student to passionately impact the world for Christ.

Core Values: Biblical Truth, Excellence, Relationships, Servanthood, and Integrity

II. Identify the demographic data of the school and the community that it serves

Liberty Christian High School is a non-public, non-denominational, 9th – 12 grade Christian school operated by Liberty Christian School, Inc. Liberty Christian High School opened in 1981 and graduated its first class in 1985. Liberty Christian High School currently has an enrollment of 156 in grades 9 – 12. The student to teacher ratio is 10:1. Liberty Christian High School's enrollment has increased over the past three years. The campus is located in a residential area containing a mixture of white, Hispanic, and African-American residents.

Liberty Christian High School's students come from a mix of public schools, home schools, and other non-public schools. The majority of our students reside in Madison County. However, several students travel as much as 60 minutes to attend Liberty Christian High School. The students represent a cross-section of families, coming from urban and rural settings, from blue-collar to management and self-employed homes, and both single and two-parent families. These families come from over 70 different churches. Minority students represent about 15% of the student body (See Attachment A) and play active roles in all parts of school life. Students' abilities range from honor students to those with special needs who participate in our Talent Development Lab services. Liberty Christian High School maintains an excellent working relationship with Anderson Community School Corporation to help with special needs students. Over 95% of the graduates choose some form of post-secondary education. Liberty Christian High School provides tuition assistance to qualified families. Liberty also partners with Sagamore, a scholarship granting organization, and Indiana's Department of Education as a school choice scholarship school.

Liberty Christian High School recognizes that its faculty is the single most important factor in determining the quality of education delivered. Thus Liberty Christian High School places a high priority on the training, ability, experience, and character of its faculty and staff. The faculty consists of degreed teachers who have training in the areas they teach. The number of teaching faculty is eighteen with a support staff of one guidance coordinator, one principal, two business office/finance personnel, two secretaries, one admissions director, and one director of development. The average teaching experience of Liberty Christian High School's faculty is 9.68 years. Six of the secondary teaching faculty have masters' degrees. With Liberty being a Christian high school, two of the full-time faculty members have a degree in Biblical studies.

The administration of the high school includes a principal who has four years of experience as a teacher and three years of experience as a principal; the principal has a Specialist in Education degree in Educational Administration and Supervision. Liberty Christian's new superintendent as of June 1, 2013, has an Ed. D and has been an elementary education professor for seventeen years. The superintendent's previous administrative experience is five and one-half years.

Liberty Christian High School's demographic indicates that the school is more diverse than it was at the last time of petition and renewal for freeway accreditation. The school is proud to have grown in diversity and to mirror the community's demographic more accurately.

III. Describe how the school's curriculum will comply with the Common Core Standards adopted by the State of Indiana

Liberty Christian High School currently follows the Indiana Academic Standards in educating students. The Common Core Standards were initially set to take effect in the 2014 – 2015 academic year. However, in May of 2013, the Common Core Standards were put on hold for the State of Indiana. The State Board of Education will vote in July 2014 regarding the Common Core State Standards and if Indiana will move forward with them or continue using the Indiana Academic Standards.

Liberty Christian High School desires to comply with the standards that Indiana chooses to endorse, whether they be Common Core or Indiana Academic Standards. As Liberty works on its reaccreditation with the Association of Christian Schools International, a complete curricular and standards review will take place. At that point, Liberty will continue updating its rigorous curriculum with the State Standards or the Common Core, whichever one is endorsed by the State of Indiana.

Liberty Christian's high school principal has created professional development sessions regarding math implementation of the Common Core, and during the 2013-2014 school year, will work on professional development for English in the event that Indiana moves to the Common Core Standards.

IV. Describe the plan allowing students to earn an Indiana Academic Honors Diploma where applicable

Liberty Christian High School offers the Indiana Academic Honors Diploma in addition to the Core 40 Diploma.

The requirements to receive an Indiana Academic Honors Diploma, students must maintain a grade-point average of 3.5 and take a minimum of two dual credit courses.

V. Freeway accreditation requires educational benefits for students in the school's attendance rate, student performance on ISTEP+ and end-of-course assessments, and for high schools, an improvement in graduation rates

- Describe the school's strategies to meet these improvements in performance
- Describe any additional measures that will be used to measure student achievement and growth.

Liberty Christian High School will continue to require Bible courses, chapel attendance, and Biblical integration in the classroom to ensure that a Christian worldview is taught.

End-of-Course Assessments will be given annually to Algebra I students, English 10 students, and Biology students who have completed those courses. Retest opportunities are also given for students who do not pass Algebra I and English 10 initially after they have received more instruction and the opportunity to learn and grow. Sophomores and Juniors also take the PSAT test to help them prepare for the SAT test. The ACT and SAT tests will be utilized to ensure our students are properly prepared for higher education.

Attendance and graduation rates will continue to be monitored. Average daily attendance is 95%; truancy is nearly non-existent. Average graduation rates since the last petition and renewal in 2008 are 95.28%. Liberty Christian High School desires to see every student graduate, and to that end faculty continue to make themselves available to tutor students who are working on either credit recovery or completion for required graduation credits. Continual follow-up with families also will assist in improving the graduation rate. Faculty also work hard to keep students engaged in learning, and Liberty Christian High School has a 96% student engagement level as evidenced by academic walkthroughs completed by the high school principal.

Liberty Christian High School will continue to gather information from stakeholders (students, parents, faculty, and staff) for input about how to measure goal attainment. Surveys are administered occasionally to assist with data collection.

In addition to meeting the minimum education benefits of attendance, performance on ECAs, and graduation rates, Liberty Christian High School will provide the additional minimum education benefits.

1. A Christ-centered environment which teaches a Christian worldview enabling students to integrate this view into their daily lives.
2. High academic standards which emphasize the basic fundamentals of education to enable the students to read with understanding, write and speak clearly and effectively, compute with accuracy, think and reason in a logical manner while developing their individual

skills to their fullest. Upon graduation students are equally prepared to find employment or enter institutions of higher education.

3. A recognition and utilization of God's gifting to live a civically responsible, culturally relevant, and spiritually pure life. Possessing a quality education, the student will be equipped with the necessary skills to successfully pursue opportunities in education, vocation, and ministry.
4. High spiritual and moral standards that enable the student to place the proper emphasis and values on all areas of life and to seek god's will in every issue.
5. A personalized approach which strives to recognize the abilities of each student and to meet individual needs.
6. Student involvement in relevant community service projects appropriate to age and ability levels.
7. An approach to physical development which teaches respect and care for their bodies as the temples of the Holy Spirit and as an instrument for God's service.

VI. Describe the curriculum strategies to address: character education, hygiene, alcohol and drugs, diseases transmitted sexually, honesty, respect, abstinence, and restraint

Liberty Christian High School is committed to providing a Christian education that includes spiritual and moral training from a Biblical perspective. Liberty Christian High School addresses the above issues in a variety of ways. The Bible provides the philosophical basis for conduct and practice in these areas. These Biblical truths are taught in Bible classes. Because of a desire for Christianity to permeate a Liberty Christian High School student's lifestyle, these Biblical teachings are integrated throughout the school day in science courses, health courses, athletics, and other extra-curricular programs.

VII. Describe how students with special needs will be identified, referred to the local public school for testing, and how IEPs for these students will be part of their instruction

Liberty Christian High School has an excellent working relationship with Anderson Community Schools. The partnership that has been forged in order to serve students is strong. Liberty Christian High School has a special education lab called the Talent Development Lab. The lab director oversees, directs, and helps identify students with special needs and getting those students the assistance they need.

Students are identified by either a parent or a teacher. The lab director then begins by working with Response to Intervention (RTI) strategies to see if those additional strategies will help the student. If those strategies are not successful, then referral paperwork is completed by the pertinent parties, and the paperwork is submitted to Anderson Community Schools (ACS). ACS then evaluates the paperwork and determines if testing is required. ACS conducts the testing and observations if required, and then the lab director coordinates all parties for a case conference.

Case conferences are then held. The case conference is lead by the Anderson Community Schools teacher of record and/or Anderson Community Schools school psychologist. The Liberty Talent Lab Director also attends along with the high school principal, the student's parents (in person or when unable to attend, by phone), as well as a teacher from Liberty Christian. At the case conference results of the tests and observations are shared, and a teacher also attends the conference (or maybe more than one) to share their observations of the student's strengths and weaknesses. Procedural safeguards are shared with parents, signatures are collected, and goals are established to benefit the student with special education services if the testing and observations indicate that services are required.

The lab director then works to incorporate the newly identified special needs student into the lab schedule if services are needed and prepares communications to share with the faculty regarding the appropriate accommodations or modifications for the student. If students require extended time on tests or that tests be read to them, they utilize the lab for those additional services. The lab director also follows up with teachers to make sure they are implementing the required strategies.

Annual case conferences are held for students who have IEPs or Individual Service Plans as they are known in the private sector. Liberty Christian High School is blessed to have a resource lab such as the Talent Development Lab and a lab director to enable the school to meet needs of students.

VIII. Identify statutes and rules to be suspended as a result of this contract

As a Christian school, Liberty Christian High School's program is driven by its mission and vision statements along with the supportive board policies. Liberty Christian High School consciously and intentionally seeks to instill within its students a Christian worldview. To this end, Liberty Christian High School requests to suspend the following statutes and rules:

- IC 20-30-5-8 (safety education)
- IC 20-30-5-9 (health education)
- IC 20-30-5-11 (alcohol, tobacco, drugs including prescription drugs)

The principles for safety education, hygiene/safety science, and health instruction are purposefully being taught in our health courses, science courses, and Bible courses. These principles are taught, practiced, and modeled throughout the school day. Liberty Christian High School maintains a unique educational distinctive in the areas of Biblical integration and character development as it pursues its mission statement. Inherent in its Christian worldview are morals such as selflessness, servanthood, stewardship, care of oneself, respect for one's body, respect for other persons and others' items or property, abstinence from immoral and damaging actions, and training in self-control and self-discipline.

The following statutes and rules concerning textbooks:

- IC 20-26-12-24 (local adoption process; adoption from state list)
- IC 20-26-12-26 (textbook rental)
- IC 20-26-12-1 (purchase and rental of textbooks)
- IC 20-26-12-2

The flexibility to choose textbooks other than those adopted by the state is needed in order to fulfill Liberty Christian High School's mission and purpose. Liberty Christian High School is committed to choosing textbooks and instructional materials that support and complement its mission and purpose according to Biblical principles. Liberty Christian High School reviews its entire curriculum every five years as part of the reaccreditation process with the Association of Christian Schools International (ACSI); faculty committees are established to conduct curricular reviews. Textbooks are also adopted on a textbook adoption rotation, and curriculum is reviewed and rewritten as necessary with those adoptions.

All the above rationales support Liberty Christian High School's request to be exempt from the stated statutes and rules.

IX. Describe how technology will be integrated into student instruction

Liberty Christian High School integrates technology into student instruction in a variety of ways. In classrooms, teachers often use laptops or tablets to share Power Points that accompany lectures or to stream appropriate and related video clips in the subject matter. Additionally some teachers are recording Power Points, Prezi presentations, and/or lectures via Jeng to provide for individualized instruction. Teachers have a website they maintain to allow students and families to see homework assignments for the week as well as ongoing projects or class requirements. Some teachers have recorded lectures or readings and had those available on their websites to assist students as well. Several departments use Google Docs as a way to give instant feedback on writing for editing and revision purposes.

Students may bring their own technology devices, such as laptops or tablets and smart phones in some classrooms, to use for research and/or note taking purposes. The computer lab may also be used during the day for students when computers are available. The library also has several laptops available for student and/or classroom use.

X. Describe procedures/plan to ensure a safe and disciplined learning environment

Liberty Christian High School believes that a safe, secure learning environment is crucial to a quality Christian education. Liberty Christian High School admits students of families that share its mission, philosophy, and goals. All families receive a Student Handbook. All parents and secondary students sign an agreement stating that they will uphold the policies of Liberty Christian High School.

Frequent communication between administration, faculty, students, and parents occurs through conferences, phone calls, newsletters, bulletins, the website, and mailings. Intercom calls, emails, and phone calls are used for intracampus and intercampus communication.

Faculty, staff, or coaches are assigned to supervise before and after school care and extracurricular programs. School day activities, such as lunch and passing period times, are supervised by faculty or staff.

The facilities are well-maintained and cleaned by a maintenance and custodial staff.

Fire and tornado alarm systems function properly and drills are run on a regular basis as required by law.

Liberty Christian High School is a closed campus. All exterior doors are locked during the school day with a buzzer/camera system allowing entrance to screened individuals. Procedures for school visitors require them to report to the office, sign in, and receive a pass. There are signs that direct visitors to the office.

XI. Describe plans for continuing professional staff development

Liberty Christian High School recognizes the importance of faculty members being lifelong learners, and several professional development opportunities are offered throughout the school year for faculty to continue to learn and grow in their professional practice.

Prior to the start of the school year, Liberty Christian High School faculty and staff gather for a luncheon to catch up with one another from the summer activities. Then, the first two days prior to the start of school are professional development days. These days are filled with sessions led by the administrative team or a guest speaker often setting the goals for the school year and reviewing the focus for the particular year.

Monthly faculty meetings are required and in those meetings, professional development continues. For example, for the 2012-2013 school year, instructional strategies was a focus in the faculty meetings with either the principal or an expert faculty meeting leading the meeting regarding a variety of strategies, such as active participation, small group instruction, developing and using rubrics, technology, etc.

As funds permit, Liberty Christian High School faculty also attend a two-day professional development seminar in the fall sponsored by the Association of Christian Schools International. If the necessary funds are not realized in the budget to attend the conference, Liberty Christian administration sponsors a two-day in house professional development time. An example of this was when faculty met in subject teams to discuss and review curriculum and vertical and horizontal alignment.

Professional development money is also available on an annual basis, and several high school faculty members have attended their subject-area state and/or national conference, or a conference that arises that is of particular interest to the faculty member. Additionally, the Association of Christian Schools International (ACSI) has several webinars and training videos available on its website, and faculty members may utilize that to maintain their ACSI certification.

XII. Confirm the school's commitment to Indiana's minimum 180 instructional days for students

Liberty Christian High School is committed to offering an excellent education to its students, and in so doing, Liberty Christian commits to adhering to the minimum 180 instructional day requirement. Liberty Christian High School has offered, and will continue to offer 180 instructional days for students.

XIII. Describe the school's ability to produce and submit all required electronic state student data reports

Liberty Christian High School has the ability to produce and submit all required electronic state student data reports as required for the Freeway Accreditation Status and the School Choice Scholarship Program. Liberty Christian High School utilizes Power School, and a Power School Coordinator, also known as our Student Information Manager, is responsible for data reporting to the Indiana Department of Education. It is Liberty Christian High School's desire to meet the requirements in an efficient and excellent manner.

Appendix A: Copy of the governing body's policy requiring new employees/volunteers to provide a current expanded criminal background check

Prior to the 2011-2012 school year, Liberty Christian High School performed background checks on any new employee or volunteer. With the advent of becoming a School Choice Scholarship School, expanded criminal background checks were required. At the time of becoming a School Choice Scholarship School, Liberty Christian High School then conducted expanded criminal background checks, and has faithfully continued to do so since that time. While there is no board policy that incorporates the expanded criminal background check, it is a part of the school choice scholarship application the Liberty Christian High School submitted in July 2011.

ASSURANCES

As a condition of becoming an eligible school, the school must affirm the following assurances by the representative's signature:

School will administer accountability assessments including Indiana Knowledge Testing (I-KT), Indiana Progress Plus (I-IPP) and End of Course Assessments (EOCAs) to all students in the testing grade levels and participate in all required training and faculty meetings.

School will not discriminate against any person, student, based on race, color or national origin, and will follow the school's anti-harassment policy in regard to choice scholarship students.

If the average of a school's four enrollment in an eligible school under a Choice scholarship exceeds the maximum of Choice scholarship students available to the eligible school, the school will create a list of students in a public meeting, in order of date of application, who are entitled to a Choice scholarship, accept the applicants who meet the requirements for admission to the eligible school.

School will not transfer a Choice Scholarship to another student.

School agrees to limit IDCE via a prescribed number of (5) business days after choice results are published, including withdrawal or appeal.

School will comply with all applicable requirements in the State of Indiana may be required, or if future provisions may be added, as a result of the withdrawal or expulsion of a student.

School agrees to participate in any data collection required by the government pursuant to IC 20-11-4.7, IC 20-11-4.8, IC 20-11-4.9, or IC 20-11-4.10.

School understands and agrees to the requirement that parent is notified sign a data release provided by the department for the distribution of records, as a condition of data collection.

Upon eligibility, school agrees to complete and file a vendor application with the Indiana Auditor of State.

School agrees to provide prospective parents with a statement that lays out the required fees, including whether the school participates in the Home Education Fund Program. School acknowledges that any fees in excess of the amount of the scholarship will be the responsibility of the parent.




