The Board of School Trustees, Elkhart Community Schools, has submitted the attached Resolution to amend its governing body selection plan to provide for the transition in electoral districts to reflect the population change outlined in the 2010 decennial census. The Board has tendered the certificate from the Elkhart County Circuit Clerk indicating no protests or counter-petitions have been filed as well as a publisher's affidavit indicating satisfaction of the publishing requirement of I.C. 20-23-8-14.

The plan as submitted satisfies the requirements of I.C. 20-23-8 and is recommended for approval by the State Board of Education pursuant to I.C. 20-23-8-15.

**RESOLUTION OF THE BOARD OF SCHOOL TRUSTEES  
ELKHART COMMUNITY SCHOOLS**

BE IT RESOLVED that, pursuant to the requirements set forth in Indiana Code 20-23-8-8 (4), the Board of School Trustees for the Elkhart Community Schools has reviewed the population living in each electoral district from which board members are elected and concluded that due to changes in population in those districts that redistricting is necessary.

Information gathered during the 2010 decennial census shows that the districts presently have the following populations:

District A: 22,517  
District B: 21,592  
District C: 16,869  
District D: 14,398

In order to meet the requirements of Indiana Code 20-23-4-35 and 20-23-8-8 (4) the boundaries for the four (4) electoral districts from which members are elected shall include the following precincts or portions of these precincts that are within the Elkhart Community Schools boundaries:

District A: Cleveland 01, 02, 03, 04, 05, Osolo 01, 02, 03, 05, and Washington 01, 03, 04  
District B: Osolo 07, 08, 09, 10, 11, 12, 13, 14, 15, and 16, Washington 02  
District C: Cleveland 06 and 07, Concord 01, 02, 03, 04, 05, 06, 07 and 08, Osolo 04 and 06  
District D: Concord 09, 10, 11, 12, 13, 14, 15, 16, 21, and 25

Subsequent to the approval of this resolution by the Board of School Trustees and certification by the State Board of Education, the electoral districts shall have the following populations and their populations shall be as near as practicable equal, according to the 2010 decennial census:

District A: 19,364  
District B: 19,233  
District C: 18,756  
District D: 18,198

This Resolution shall be effective upon approval by the Board of School Trustees, publication and certification by the State Board of Education.

Voters of the Elkhart Community Schools corporation may file petitions for alternative plans or a petition protesting the adoption of the plan described in this notice, pursuant to Indiana Code 20-23-8-14.
