FINAL ORDER OF THE STATE EMPLOYEES' APPEALS COMMISSION

On November 13, 2018, the assigned Administrative Law Judge (ALJ) issued notice and a copy of "Findings of Fact, Conclusions of Law and Non-Final Order of Administrative Law Judge" granting summary judgment to Respondent Indiana Department of Transportation ("Respondent") (the "ALJ's Order"), which is hereby incorporated by reference as if fully set forth in this document.
