- III. Update from the Secretary's Office
 - a. Updates from Secretary Morales
 - Thank you to all the members. Appreciation to President Trump for his continued FinCEN efforts. Sec. visited 92 counties in 3 months to continue to get feedback. Meeting regularly with small business owners. Promoting In My Community. Business Services outreach, spoke to County Recorders today.
 - b. Legislative Update 2025 (Mr. Prentice)
 - i. Last day of session.
 - ii. HB1666-collecting ownership information for healthcare entities. SOS asked to obtain the data. Initiative determining if larger healthcare groups buying up smaller entities.
 - c. Progress on Safe Harbor HEA-1623 (Mr. Willis)
 - i. EA Fees 29 days in public comment period. If there are no objections go to AG's office next week.
 - d. FinCEN update (Mr. Willis)
 - i. Narrowed down for entities created in a foreign country.
 - e. Update to HB 1593 (Mr. Willis)
 - Fraud Bill signed, effective 01/01/2026. State to implement better ID verification. Creates Contact Address for a business to keep personal information private. Increasing connectivity to businesses.

 - a. New Commission candidates to be approved (Chairman Becker)
 - i. Approved 3 people last meeting. Now that the session is over, hopefully the Governor will have time to approve candidates and get them on board.
 - ii. Mr. Becker conversing with two additional candidates.
 - iii. Hoping to have the Governor appoint all 5 at the same time.
 - b. Update on Comments to LLC Act (Mr. Sullivan)
 - i. 60-65% finished and looking to make progress over the summer.
 - c. Indiana Code 6-8.1-10-9.5 Sales tax clearance process for M & A transactions (Mr. Hollingsworth)

- i. Tax statute against businesses filing 45 days prior to the transaction. Ensures the seller pays all their taxes and if not, buyer is responsible. Circulating proposed changes, not yet submitted to DOR.
 - a. Proposed changes
 - i. Streamline process. 45 days impractical
 - ii. Transfer is broadly defined.
 - iii. Mr. Willis suggesting that business ID be added to DOR database
- V. New Business / Future Projects
 - a. Model Business Corporation Act task force update (Mr. Hollingsworth)
 - i. Taskforce has been meeting
 - ii. Improving law, leading jurisdiction, state of the art law
 - iii. Is statute change necessary or can a change be made in commentary
 - iv. Recommendations potentially in the Fall
 - b. Hub Meta changes task force update. (Mr. Sullivan)
 - i. Will pursue progress over summer 2025.
 - c. Other projects 2025 (Chairman Becker)
 - i. Updates to corporation act, make sure we aren't impacting PC statute

 - iii. Simon is looking to re-domesticate from DE to IN
 - 1. IN law sufficient. As good or better than DE law.
