1 Introduction

Bulk download data is generated into seven flat text files. The files are organized as tab separated text with a single record on each line of the text file. Fields within the data files are separated with tab characters and are not delimited.


The tables generated are named the following:

1. Corporations Table
2. Filings Table
3. Agents Table
4. Officers Table
5. Names Table
6. Mergers Table
7. Reports Table

Only the most current amalgam of information for entities and reserved/registered names is provided. No attempt is made to provide an association between filings and the changes to entity, agent, officer, names, merger, or reports data made by the filings.

2 Table Relationships

Packet Number fields relate the tables with one another. The following diagram identifies the relationships between the tables:

3 Corporations Table

The Corporations table contains one record for each Entity, Reserved Name or Registered Name. Each record is uniquely identified by a Packet Number value.

The Entity Type field defines the type of an entity, reserved name or registered name. The Original Inc State, Original Inc Date and Fictitious Name fields are only valid for foreign entities. The Managers field only applies to Limited Liability Companies (LLC's). The Owner Name field is only valid for a reserved or registered name.

The Creation Date field identifies the effective date of the filing that creates the entity or name. The Expiration Date field is used to indicate when an entity or name will expire. The Inactive Date field provides the effective date of the filing that takes the entity or name out of existence. Because filings can have post-effective dates, the Status, Creation Date, Expiration Date, and Inactive Date fields must all be considered when determining the status of an entity or name.

The Status field indicates the status of the entity or name as of the effective date of the most recent filing for the entity or name. An entity or name with a status code of Active will not be active until after the date indicated by the Creation Date field. An entity with a non-Active status code will be Active until the date provided by the Inactive Date field. In addition, an entity with an Active status that has passed the Expiration date is expired.

For entities, the Address Line 1, Address Line 2, City, State, Zip Code and Zip Extension fields identify the principle address of the entity. For reserved and registered names these fields identify the address of the owner of the reserved or registered name.

Note: Most miscellaneous entities do not have an agent record. Some of the regular entities may not have an agent record. Reserved and registered names should never have an agent record.

The Mergers table identifies what entity was the survivor entity when a specific entity was merged out of existence by an Article of Merger, Certificate of Merger, Notice of Merger, or Consolidation filing. Because an entity may only be merged out of existence once, the unique identifier for merger table record is the Non-Survivor Packet field.

9 Reports Table

The reports table stores the years for which Business Entity Reports have been filed for the entity. Records are uniquely identified with the Packet Number and Year fields.

Only entities that are required to file Business Entity Reports will have records in this table.

When an entity type is required to file biennial reports, only the first year of the two year period is significant in determining if a filing has been made.

The Locator fields if present is reference number used to locate actual filing paperwork in the offices of the Secretary Of State.
