
Please accept from the Cass County Election Board Members this amended information about our vote center plan.

All paper ballots will be counted using Hart Intercivic Election Equipment. Cass County will use both Hart components that can be used for counting paper ballots, the Ballot Now Scanner and as Escan. The Ballot Now scanner takes an image of each ballot as they are fed through a scanner in groups of 25 ballots. After all ballots are scanned the county election board will review any over votes or improperly voted ballots on the Hart Ballot Now Software and determine voter intent. The Escan unit will also be used to count paper ballots. The Escan takes each ballot one at a time and scans it. The Escan unit then rejects the ballot if it is over voted or improperly voted. The election board will then determine the voter intent and transfer that intent onto a new ballot and feed it through the Escan unit. The Escan will not be taking the place of the Ballot Now Scanner. They both will be available to be used.






