

Dear Governor Holcomb,

It is with great sorrow and deep sadness that it is my statutory responsibility to inform you that I, Christopher Anderson, Clerk of the Circuit/Superior Courts of Elkhart County, State of Indiana, have been notified of the tragic passing of U.S. Representative Jackie Walorski, on Wednesday, August 3, 2022.

Based on Indiana Code 3-13-3-2(a), this letter shall serve as certification to you as Governor, that an elected office vacancy now exists in the Office of U.S. Representative District 2 for the State of Indiana.

While this elected office vacancy, and the subsequent ballot vacancy, creates numerous administrative election responsibilities for the counties that constitute U.S. House District 2, the ultimate responsibility of whether or not to call the special election to fill the unexpired term of Representative Walorski rests squarely on your shoulders. I do not envy you in this task.

Please know that the County Clerks and Election Administrators around the State, particularly and specifically in the 2nd Congressional District, and the Indiana Election Division, stand ready to implement your Writ calling for a special election and will conduct said special election at the time of your choosing in a fair, impartial, and secure manner as dictated by Indiana election law.

In closing, I would like to extend my deepest condolences to you, the Indiana General Assembly and other State Officials, and the State of Indiana in general on the loss of a longtime colleague and friend. Representative Walorski will be deeply missed.

EXECUTIVE ORDER 22-12

SPECIAL ELECTION

TO ALL WHOM THESE PRESENTS MAY COME, GREETINGS:

WHEREAS, the Honorable Jacqueline "Jackie" Walorski of Elkhart County, Indiana, was duly elected in the general election of November 3, 2020, to the House of Representatives of the United States of America (the "House"), to represent the people of the Second Congressional District, Indiana (the "Second District");

WHEREAS, the Honorable Jackie Walorski took office as a member of the House, in the 117th Congress, on January 3, 2021, for a term that ends at noon on January 3, 2023;

WHEREAS, due to the tragic death of the Honorable Jackie Walorski, a vacancy exists in the office of United States Representative for the Second District; and

WHEREAS, as the 117th Congress continues until January 3, 2023, the people of the Second District are and will be without equal representation in the House;

NOW, THEREFORE, I, Eric J. Holcomb, by virtue of the authority vested in me as Governor of the State of Indiana, do hereby decree and order the following:

- Under the provisions of the United States Constitution and the provisions of the Indiana Code (Title 3, Article 10, Chapter 8), that a need for a special election now exists in the Second District;
- 2. A special election shall be held in the Second District, as that district was constituted on November 3, 2020, to fill the vacancy recently created by the death of the Honorable Jackie Walorski, as a member of the House.
- 3. Nominations shall be made pursuant to the applicable provisions of the Indiana Code, including §§ 3-10-8-5, 3-13-1-4, 3-8-6-13, 3-13-1-20, and 3-8-2-2.5.
- 4. This special election shall be held on November 8, 2022, and the candidate elected by the voters will serve for the remainder of the term of the office vacated by the Honorable Jackie Walorski.
- 5. The Clerks of the Elkhart, Fulton, Kosciusko, LaPorte, Marshall, Miami, Pulaski, Starke, St. Joseph, and Wabash County circuit courts, by this Writ of Election, are directed to hold such special election for the vacated office of the Second District, in accordance with the laws of the State of Indiana.
