

FOURTH AMENDMENT TO JOHNSON COUNTY VOTER CENTER PLAN

THIS FOURTH AMENDMENT TO JOHNSON COUNTY VOTER CENTER PLAN ("Fourth Amendment") is made and entered into as of the 2nd day of October, 2015 by the Johnson County Election Board ("Board").

RECITALS

Whereas, Johnson County adopted a Vote Center Plan ("Plan") on March 14, 2012 pursuant to IC 3-11-18.1-3;

Whereas, the Board amended the Plan on September 12, 2012 concerning Voter and Satellite Center locations ("First Amendment");

Whereas, the Board amended the Plan on February 24, 2014 concerning Voter and Satellite Center locations ("Second Amendment");

Whereas, the Board amended the Plan on February 18, 2015 concerning Voter and Satellite Center locations ("Third Amendment");

Whereas, the Board desires to amend the Plan concerning the Voter and Satellite Center locations, beginning with the 2015 General Election, pursuant to IC 3-11-18.1-15;

BE IT THEREFORE ORDERED that the Plan is hereby amended as follows:

1. Any capitalized term used herein, but not defined herein, shall have the meaning given to such term in the Plan.
2. The Section entitled "Vote Center and Satellite Vote Center Locations" of the Plan is hereby deleted in its entirety and replaced with the following:

Vote Center locations open on Election Day, November 3rd (6:00 AM - 6:00 PM):

1. Edinburgh Public Library, 119 W. Main Cross St, Edinburgh, IN 46124
2. Bargersville Town Hall, 24 N. Main St., Bargersville, IN 46106
3. GracePoint Church, 330 Whiteland Road, New Whiteland, IN 46184
4. Clark Pleasant Public Library, 530 Tracy Road, New Whiteland, IN 46184
5. Community Church of Greenwood (Main Entrance Foyer), 1477 W. Main St, Greenwood, IN 46142
6. Greenwood Community Center, 100 Surina Way, Greenwood, IN 46143
7. Greenwood Christian Church, 2045 Averitt Road, Greenwood, IN 46142
8. White River Public Library, 1664 Library Boulevard, Greenwood, IN 46143
9. Mt. Auburn Methodist Church, 3100 W. Stones Crossing Road, Greenwood, IN 46143
10. Greenwood City Hall, 300 S. Madison Ave., Greenwood, IN 46142
11. Rocklane Christian Church, 4430 Rocklane Road, Greenwood, IN 46142

3. The Board, by a unanimous vote of the entire membership of the Board, approved the Third Amendment on _____, 2015.

4. The Fourth Amendment shall become effective upon its filing with the Indiana Election Division.

5. The terms and provisions of the Plan not specifically modified by this Fourth Amendment shall remain in full force and effect and shall not be construed to have been modified, waived, discharged or otherwise altered by this Fourth Amendment.

6. The terms and provisions of the Plan are incorporated herein by reference as if fully stated herein. To the extent the terms of this Fourth Amendment conflict with the terms of the Plan, the terms of this Fourth Amendment shall control.

7. This Fourth Amendment may be executed in several counterparts, each of which shall be deemed to be an original but all of which together shall constitute one and the same instrument.


