BE IT THEREFORE ORDERED BY THE PULASKI COUNTY ELECTION BOARD:


The following location will be added as an additional satellite location to be used if needed for in-person absentee voting on the two Saturdays proceeding Election Day beginning with the General Election

Further, this resolution shall take effect immediately and may only be rescinded by unanimous vote of the entire membership of the Pulaski County Election Board.


