Indianapolis Area Substance Abuse Professional (SAP) Information

Review the following information prior to contacting a SAP:

When calling for appointment, explain to the person answering the phone you need to set an appointment with a Substance Abuse Professional (SAP) for an evaluation as required by company policy because you have tested positive on a drug or alcohol test. Specify if the evaluation is needed for DOT compliance.

The SAP may ask for information on your test result, such as what you tested positive for, the level or other information. If you or the SAP need additional information on the test result, call Midwest Toxicology Services at 317-262-2200 or 800-358-8450 and ask for Sharon Allen, ext. 203 or Tiffany Ellefson, ext. 205.

All SAPs performing services should have one of the following credentials:
Substance Abuse Professional (SAP):

- a licensed physician (medical doctor or doctor of osteopathy), **or**
- a licensed or certified psychologist, licensed or certified social worker, employee assistance professional **or**
- an alcohol and drug abuse counselor certified by the National Association of Alcoholism and Drug Abuse Counselors (NAADAC) Certification Commission

All must have knowledge of and clinical experience in the diagnosis and treatment of substance abuse-related disorders (the degrees and certificates alone do not confer this knowledge).
